

## Ordering Certified FINOLA Planting Seed for 2018

### Dear Customer,

To order your OECD certified C-1 FINOLA planting seed for 2018, please read these instructions carefully. This seed is packaged for commercial distribution in 25 kg bags. Each bag has only one official certification tag. The certification tag is required to apply for the European Union crop subsidy. For customers in the USA- you must have a DEA import permit and a supporting letter from your State Department of Agriculture, before we can begin to discuss your order.

**We suggest a seeding rate of 25-30 kg/ha.** Good soil conditions, sufficient fertilization and correct sowing depth are essential for this variety. Please read our basic farming information on this page: <http://www.finola.fi/>.

Order less than 25 bags may be sent to one of our distributors in Central Europe. Please contact me by e-mail to discuss prices for orders over 120 bags.

**A handling fee of €75 plus €1/bag is added to each order.** This fee includes labor, the pallet, packing, wrapping, loading and shipping documents.

### Ordering your SEED

**After placing your order**, an invoice will be sent to you by e-mail. This invoice will include the cost of the seed, a quote for door-to-door transport costs and the handling fee mentioned above. If you are in the European Union, and if you do not have a VAT number, a tax will be automatically added to your invoice.

**All orders must be paid by direct bank transfer before shipping.** We do not accept payments by credit card. After we have received your payment by bank transfer, your seed will be sent. You will also receive an estimation of the expected delivery date for your seed and the CMR tracking code (upon request).

**Our responsibilities do not include** possible taxes in your country, or insurance on the shipment.

**If you are ordering from outside of the European Union;** import and export permits are required, in addition to phytosanitary documents. Be sure to understand that it will be your responsibility to receive this shipment at your nearest port of entry, clear it through your customs and agricultural inspections, pay any additional importation taxes or fees, and eventually organize your own transport to a final destination. We do not do this for small orders.

### **Current status of FINOLA in the European Union**

FINOLA remains on the EU Commission's list of approved hemp varieties, and European farmers are entitled to a subsidy for cultivating FINOLA in all 28 EU Member States, including the United Kingdom. If field samples are still collected for THC testing in your country, please be sure to help your agricultural officials plan for the correct time to collect FINOLA field samples; about 55 days after sowing. Also, please inform us if FINOLA samples are collected from your field at a later date.
